ORDER:-

The Secretary Cum Correspondent “NEXZEN EDUCATION TRUST” has applied for grant of Provisional Recognition for classes I to VII (EM) in the name Sri Chaitanya School, Kothapalli, Proddatur Mandal, YSR District for the academic years 2023 – 2024 to 2030 – 2031.

The Inspecting Officer i.e., Mandal Educational Officer, Proddatur Mandal caused inspection and submitted his report in the reference 8th read above.

In exercise of powers conferred in the G.Os 1st to 6th read above and after careful examination of the proposals of the Society and on due consideration of the inspection report of the Inspecting Officers in the reference 8th read above, for the grant of provisional recognition is hereby accorded for the classes I to VII (EM) in the name of Sri Chaitanya School, Kothapalli, Proddatur Mandal, YSR District under the management of “NEXZEN EDUCATION TRUST” for the academic years 2023 – 2024 to 2030 – 2031 without aid now or in future subject to fulfillment of the following conditions.

- 1) That the society shall abide to the rules and regulations made in the Govt. orders 1st to 6th cited above.
- 2) That the society shall apply for recognition by 31st August at the latest duly fulfilling the conditions.
- 3) That the Society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking water facilities, Furniture, Library, Laboratory equipment, Play field, required staff as per the Staff pattern and other facilities are necessary before approach the competent authority.
- 4) That the permission accorded is restricted to these years only and it is not valid for the subsequent academic year.
- 5) That this permission does not confer any right on the society for claiming recognition. That the permission is accorded to “NEXZEN EDUCATION TRUST” and no other society or body can open a School on their behalf.
- 6) The permission is accorded to open the School premises in the locality and there shall not be any change in the premises of locality.
- 7) The society shall provide the necessary material even if it costs more than the deposit amount.

- 8) The Society shall submit the No objection Certificate from the Department of Fire Services while submitting the proposals for grant of Renewal of recognition, if failed so, the District Educational Officer, YSR District is liable to withdraw the permission without any prior notice.
- 9) Those Teachers who are working in Private Schools without possessing pass TET being conducted by the Andhra Pradesh School Education Department should invariably attend the TET and the managements should confirm their appointment only after passing the TET along with their regular qualification of D. Ed. / B. Ed, and other conditions stipulated by the Government from time to time.
- 10) Management should ensure to pay the minimum salaries to the Teachers by 1st of every month through bank.
- 11) All the Managements should ensure to reach every benefit like Gratuity, Teachers Provident Fund, Group Insurance Scheme etc., to the Teachers and other staff as per Rule 18 of G.O. Ms. No. 1 Education Department, dated: 01.01.1994.
- 12) All the Management should issue Identification cards to the staff working in their schools.
- 13) All the Managements should submit their Annual Administration Report in the prescribed proforma to the competent authority for very financial year by the 30th September.
- 14) The Inspecting Authority (Mandal Educational Officer) inspect and verify the accounts including payment of the salaries and other ben
- 15) efits like Gratuity, Teachers Provident Fund, Group Insurance Schemes etc., to the staff.
- 16) The management should upload the fee collected by them during the academic year 2023 – 24 in CSE.AP.GOV.IN website and also display in two prominent places visible to public in respective school premises.
- 17) The Management shall submit the proposals for Additional Sections through the Mandal Educational Officer, Proddatur in accordance with the strength of the school immediately, if failed so, the District Educational Officer, YSR District will have the right to cancel the Renewal of Recognition issued in these proceedings.
